ELIGIBILITY:

All participants must meet the following requirement.

- 1. This event is open to all participants of Taekwondo all belts from the age of 6 years onwards.
- 2. The Black Belts must have their Dan or Poom Kukkiwon certification or duly certified.
- * A copy of your certificate of Kukkiwon must be submitted when registering and require accreditation. If this requirement is not met, the competitor will not be accepted to participate.
- ** For obtaining the certificate later Dan / Poom of the Kukkiwon which is in progress, a copy of the application form and the certificate of payment of Dan / Poom which was sent to the Kukkiwon must be delivered to the registry for accreditation. Please refer to the website of the Kukkiwon (www.Kukkiwon.or.kr) for more information.

AFFILIATES:

All participants must have the nationality of the country they represent.

TEAM COMPETITION RULES AND STANDARDS PERMITTED

COMPETITION RULES:

WTF Rule Changes and age divisions

On December 26, 2012, the WTF has made changes to its age classification. These changes are as follows:

SPARRING:

- Juniors = 15-17 years
- Seniors = 17 + years (anyone 17 and older can compete in the Senior Division)
- Cadets = 12-14 years

POOMSAE

- Junior = 15-17 years (individual, pairs, Team)
- 1st senior = 18-29
- 1st Pair = 18-29
- Cadet = 12-14 years (individual, pairs, Team)

Current WTF Competition Rules / PATU

6–13 Open Divisions will use modified junior combat safety rules. Current Rules Sport Poomsae (WTF reduced format) WTF / PATU

TEAM:

PATU / Mexican Taekwondo Federation will be using KP&P Scoring System (PSP) approved by the WTF at the Pan American Taekwondo Open Championship 2013. Athletes can rent this equipment for the cost of \$ 20.00 for the duration of the event of combat. If athletes have their own equipment PSP they may use it in combat competition. The PATU provide complementary use of PSP for all international athletes. However, all foreign athletes must provide their own socks with electronic sensors to combat competition. Athletes from all Belts are required to have and use the PSP sensor sock. The PSP sensor socks can be purchased by visiting the store in the event PSP.

All athletes are responsible for bringing their own protective headgear, gloves, feet, arms, shin guards and mouth guards.

OFFICIAL UNIFORM: (Dobok)

All contestants shall wear a uniform (Dobok) Taekwondo White V-neck of the Corporation / WTF in good condition. Black Belts must wear uniforms with black neck. The ribbons should wear uniforms of white collar, colored Belts can not wear black uniforms neck. Patches, embroidered logos, team names, countries, athlete's name and stripes are allowed in uniform. No tape will be allowed in any part of the uniform.

PROTECTIVE EQUIPMENT:

Contestants must wear an approved trunk protector, head protector (white or red and blue Hong Chung), groin protector (optional feminine competitors), gloves (see below), forearm protector, instep protector, socks with sensor (if using electronic protector and Scoring System) and mouthpiece before entering the contest area. The head protector must be firmly placed under the left arm to enter the competition area and will place it on the head followed by the instructions of the referee before the start of competition. Protecting groin, forearm and upper should be worn inside the Taekwondo uniform. Using any other item on the head other than the head protector shall not be permitted. Previously approved religious articles must be worn under the protective headgear and within Dobok and shall not cause damage or obstruction to the opponent.

BELT COLORS:

Only WTF belt colors / PATU will be allowed (black, red, blue, green, yellow, orange and white). Striped belt will be allowed.

GLOVES:

14-17 years Black Belt and Black Belt Adults are required to wear gloves approved by the WTF Taekwondo. Gloves can be red, blue or white, white are preferred. However, red and blue are allowed. If the competitor chooses red or blue gloves should

match the color of your trunk protector. Gloves should be open-fingered style. For other divisions, gloves are optional and must meet that rule.

ELBOW AND KNEE PADS

The use of elbow and knee pads is OPTIONAL. Elbow and knee pads, if used, should be foam, fabric or vinyl. Any color is allowed.

MOUTHGUARD

All athletes are required to wear mouthguards. A mouth cover may be used by those with braces orthodontist if a note is provided before the start of competition. Mouthguards can be any color.

HAEDGEAR:

All participants must provide their own headgear RED and BLUE unmarked another corporate logo. Red and blue are required. If the competitor chooses to use headgear red or blue, the color must match the trunk protector. Cracks or defects in the head protector shall not be permitted.

GROIN PROTECTOR:

All male athletes are required to wear a groin protector inside the dobok during competition. The groin protector is optional for women, if used, should be used inside the uniform.

SHIN AND INSTEP

Shin and Instep are required and must be made of foam, fabric or vinyl. When they are available, socks with PSP sensors and Instep will also be allowed. If an athlete chooses to use foam protections must be taped and will cover the area from the base to the toes, on top of the instep to the side of the foot, with no more than two can tape. Shin or additional Instep must be approved and stamped by the Department of Sports Medicine in order to protect from injury. Important note: "foot gloves" are not allowed to use PSP skills.

FOREARM PROTECTION:

Forearm protection is required and mandatory for athletes to use only foam products, fabric or vinyl. Any color is allowed forearm. Note: The Mexican Taekwondo Federation reserves the right to reject any uniform or equipment if he is found offensive or demeaning in any way.

REREREES:

- 1. PATU will appoint the required number of referees.
- 2. The round trip must be paid by each participating International Referee.
- 3. The Organizing Committee will cover four (5) nights of lodging and meals (Registration early afternoon of September 18, 2013, departure before 10 am on September 23, 2013). Please note that the board of referees and training will be September 12 from 9:00 AM 6:00 PM.
- 4. The Organizing Committee will provide each participant with an International Referee daily fee of \$ 100.00 for the three days of competition (Kyoroogi, Poomsae, K5 Team Competition Adult and Youth and Open Competition Pan)

WEIGH-IN:

- 1. The weight in of the athletes must be completed the day before the day of competition.
- 2. At the weight in male competitors may wear underwear and feminine competitors may wear underwear and bra. Athletes can weight naked if they prefer.

INDEMNIFICATION:

1. Participants without proper entry form to participate and effective insurance coverage will not be allowed to compete in the championship.

Note:

(Explanation #1)

Not exceeding:

The weight limit is defined by the criteria of one decimal place away from the stated limit. For example, not exceeding 50kg is established as 50.0kg with 50.1kg being over the limit and resulting in disqualification.

(Explanation #2)

Over: Over 50.00 kg marks occur at the 50.1kg reading and 50.0kg and below is regarded as insufficient, resulting in disqualification.

- **Athletes are not permitted to enter more than one (1) weight category, per age division. **
- ** Athletes must compete in their age divisions that they fall in. An athlete cannot compete "up or down" in age divisions. **

COMPETITION RULES:

REGLAS DE COMPETENCIA:

METHOD OF COMPETITION:

Elimination System:

- 1) Preliminaries: After the completion of two (2) of the four (4) 1st Compulsory Poomsae predetermined by the Corporation, 50% of participants above qualify for the next round according to the average score of the two shows.
- 2) Final Selection: 50% of participants would have to demonstrate the remaining two (2) 1st Compulsory Poomsae. The eight (8) top athletes in each category (individual, couples and teams) will be selected according to the average score of the two shows.
- 3) Final: The eight (8) top athletes in each category would have to show two (2) of the 2nd Compulsory Poomsae predetermined by the Corporation. The classification of the three (3) top athletes in each category will be determined by the average score of the two shows.
- 4) The poomsae competitors for all ribbons will be completed in two rounds: Preliminary (50% of above advance to the final round) and the Finals.

POOMSAE FREESTYLE COMPETITION TEAM / TEAM \$ 300.00 USD

For freestyle Poomsae, each team is allowed to have a minimum of 3 competitors and a maximum of 10 competitors per team. All poomsae competitions freestyle should be performed with music. Skills Freestyle Poomsae should be completed during the 3-minute margin.
