#### **ELIGIBILITY:**

Based in Article 4' from the Rules of Competition for the World Taekwondo Federation:

1st Criterion: Athletes must be holders of the nationality from the represented Federation with valid passport.

2nd Criterion: Athletes must be recognized by the represented National Federation.

3rd Criterion: Athletes must be holders of a Dan or Poom Kukkiwon Black Belt Certificate, copy to be delivered with application form and accreditation. Contestants will not be able to participate without valid accreditation.

4th Criterion: Have a valid Global Athlete License from WTF (GAL). Any questions regarding GAL application please contact Mr. Jeremy Mallétroit, WTF Global Licenses Administrative Manager by the email gmsadmin@wtf.org.

In case that any contestant has not received yet the Dan Kukkiwon Certificate, please attach a copy of the application form and the prior Kukkiwon Certificate.

#### COMPETITION SYSTEM:

Single elimination

#### **COMPETITION RULES:**

The competition regulations will be based on those established by WTF and PATU. Current WTF Kyorugi and Poomsae Competition Rules will govern this Championships. 6 to 11-year-old Black Belt divisions will use PATU approved junior safety rules for sparring.

#### **OFFICIAL SPARRING UNIFORM:**

All Black Belt Sparring contestants must wear WTF Approved Black V-neck uniform (Dobok) in good condition.
All Black Belt Poomsae contestants from 12 years old and older must wear WTF Approved Poomsae uniform.
For all color belt contestants, colored uniforms are allowed for all events with EXCEPTION of Sparring.
For all color belt sparring contestants, WTF White V-neck uniform is required. Patches, embroidery, logos, team names, country names, athlete names, and stripes are allowed on the uniform. NO TAPE WILL BE ALLOWED ON ANY PART OF THE UNIFORM. (Exception: Taping the pant leg when using Protector and Scoring System sensor socks, with NO MORE than 2 layers of tape)

#### SPARRING EQUIPMENT:

Organizer will be using DAEDO Electronic Body Protectors at the 2015 Pan Am Open Taekwondo Championships, Aguascalientes. For all Black Belts only; cadets, juniors and seniors.

All Black Belt competitors are REQUIRED to purchase and use their own DAEDO socks for the sparring event(s). Daedo sensor socks can be purchased by visiting the Daedo sales booth at the event.

All athletes will be responsible for supplying their own headgear, gloves, foot pads, arm and shin guards, and mouth guards.

#### PROTECTIVE EQUIPMENT:

Contestants shall wear an approved trunk protector, headgear (white, or red for Hong and blue for Chung), groin guard (optional for female competitors), gloves, forearm protector, shin-instep protectors, sensing socks, and mouth guard before entering the contest area.

No eyeglasses or prescription goggles allowed.

# **PROTECTIVE GLOVES:**

All Black Belts are required to wear WTF-approved Taekwondo gloves. Gloves may be red, blue, or white while white is preferred. Competitors who choose to wear red or blue gloves must correspond with the color of the trunk protector.

Gloves must be open finger style.

For all other divisions, gloves are optional and must comply with the above rule.



















#### **KNEE & ELBOW PADS:**

The use of kneepads and/or elbow pads is OPTIONAL. Kneepads or elbow pads, if worn, must be foam, cloth, or vinyl, and must be worn under the Taekwondo uniform. Any colors are allowed.

#### MOUTH GUARD:

All athletes are REQUIRED to wear mouth guard. A mouth cover may be used for those with braces if an orthodontist's note is provided prior to the beginning of competition.

Clear or White mouth guards only.

#### **HEADGEARS:**

All Black Belt participants must provide their own red AND blue headgear with no markings other than corporate logos.

Headgear must correspond with the color of the trunk protector.

Competitors will not be permitted to wear headgears with cracks or defects.

#### PROTECTIVE CUP:

All male athletes are REQUIRED to wear a protective cup inside the pants during competition. Groin protection is optional for female athletes; and must be worn inside the uniform pants.

#### SHIN & INSTEP PROTECTION:

Shin and instep protectors are REQUIRED and mandatory to be used.

#### FOREARM GUARDS:

Forearm guards are REQUIRED and it is mandatory that athletes wear only foam, cloth, or vinyl products.

Any color forearm guard will be allowed.

Forearm guards must be used inside the competition uniform.

Before entering the FOP, all the competitors most go through Inspection Area in charge of the Technical Competition Group. Any competitor that does not achieve official uniform and protective equipment approval will not be permitted to compete. All the athletes who do not reach this approval in the electronic protective gears will be immediately disqualified according to WTF Rules of Competition.

Organizing Committee reserves the right to disallow any uniform or equipment if it is found to be offensive or degrading in any fashion.



















#### SCORING OFFICIAL SYSTEM:

DAEDO Electronic Body Taekwondo Protectors will be used in the Black Belt Competition, always promoting the spirit of Olympic "Fair Play".

Video-replay system will be used as a guarantee of fair judgment and decisions (Black Belts Competitions Divisions; Cadets, Juniors & Seniors).

#### **INTERNATIONAL REFEREES:**

PATU will appoint the required number of International Referees.

Round-trip Airfare shall be borne by each participating International Referee.

The Organizing Committee shall cover room and board expenses (From September 10 until September 14, 2015).

The Organizing Committee shall provide each participating International Referee with a daily honorarium of US\$100.00 for 3 days of competition.

Please note, referee technical meeting and training will be held on September 10, at 18.00 hrs.

#### WEIGH-IN:

Weigh-in for athletes shall be completed one day before the sparring event date. At weigh-in, contestants must wear a minimum of under-pants if decided.

Participants without proper participation entry forms and valid medical insurance coverage will not be allowed to compete at the 2015 Pan Am Open Championships, Aguascalientes.

Liability waivers must be signed by participants (or by parent or legal guardian for athletes ages 18 and under) prior to competition.

Athletes are NOT allowed to be registered in more than one sparring weight division of his age.

#### **VISA ENTRY:**

All participants are responsible for their own visas for México.

An invitation letter to the 2015 Aguascalientes Pan Am Open Championship will be available upon request.

To apply for an invitation letter please send an email to; visas@mextkd.org with the complete information of the requesting competitor or competitors.

Each contestant or National Federation must cover all the payment for paperwork.

Refund of registration fees will NOT be granted due to visa or travel arrangement issues.

#### TRANSPORTATION:

All transportation costs for arriving to Aguascalientes will be responsibility of each delegation or athlete. The transportation from the official hotels to the venue will be responsibility of each delegation.

#### **ACCOMMODATION:**

#### **POOMSAE REGULATIONS**

#### **COMPETITION RULES**

Current WTF Poomsae Competition Rules will apply.

#### COMPETITION METHOD.

All Color Belt Poomsae competitors will compete in 1 Round of Compulsory Poomsae of their choice.

Contestants shall perform one (1) compulsory Poomsae, and the top four contestants/pairs/team shall be awarded prizes based on their points.



















# **CUT-OFF SYSTEM (BLACK BELTS ONLY):**

The cut-off system shall comprise the Preliminary, Semi-Final, and Final rounds.

Preliminaries: When 20 or more competitors are participating; competition shall start from Preliminary round with division of groups at different rings. Competitors shall perform two (2) designated compulsory Poomsae, and half of each group shall advance to Semi-Final based on the average score of the two performances. In the Preliminary round, each group may be judged by different group of judges. If the number of competitors is odd, the number of competitors will be rounded to an even number. Ex) if there are 23 competitors in the division, it will be considered as 24 competitors and 12 shall advance to Semi- Final.

Semi-Final selection: When 9 to 19 competitors are participating; competition shall start from Semi-Final round. Competitors shall perform two (2) designated compulsory Poomsae, and 8 of them shall be advanced to Final based on the average score of the two performances.

Final: When 8 or fewer competitors are participating, competition shall start from Final Round. Competitors shall perform two (2) designated compulsory Poomsae, and the top four individual competitors/ pairs/team shall be awarded prizes based on their total or average points

#### **DEMONSTRATION TEAM COMPETITION:**

Registration Fee \$300.00 USD per Team.

Maximum set up time is 1 minute & clean up time is 1 minute.

The maximum time to complete the demonstration is 8 Minutes.

The demonstration should be done in the area governed by the size of WTF8m x 8m.

Minimum of three members and no more than 10 members, including board holders.

No pyrotechnics, fireworks or rockets are allowed.

Official tables or other accessories shall be provided by the demonstration team.
